A. GENERAL PROVISIONS

1. The South Carolina Education Lottery ("SCEL") will conduct the **RIVAL PLAY** Second-Chance Promotion ("Promotion") according to the rules provided in this document. The Promotion is comprised of the CLEMSON JACKPOT scratch-off game and the CAROLINA¹ JACKPOT scratch-off game with a five dollar (\$5) price point. The CLEMSON JACKPOT scratch-off game is SCEL game number SC-1419 and the CAROLINA JACKPOT scratch-off game is SCEL game number SC-1420.

The Official Rules ("Rules") for the Promotion are comprised of:

- (a) Act 59 of 2001, as amended;
- (b) the Regulations of the South Carolina Education Lottery Commissioners;
- (c) any matter adopted by the Board of Commissioners of the South Carolina Education Lottery Commission;
- (d) the material presented in this document;
- (e) the Draw Procedures for the Promotion ("Draw Procedures"), established by SCEL and Scientific Games, Inc. ("SG");
- (f) the provisions contained within the contract for the printing of the scratch-off ticket game ("Working Papers") for Game SC-1419 and Game SC-1420; and
- (g) any practices or procedures (either written or unwritten) utilized by SCEL, to include terms by the University of South Carolina and Clemson University.

2. The items cited herein are incorporated by reference and are binding as if printed herein. Each item cited above shall have equal weight unless there is an inconsistency between or among the documents, in which case the document listed first shall be controlling.
3. Amendments to these Rules, including cancellation of the Promotion, may be made at any time without notice but must be made in writing and signed by the SCEL Executive Director.
4. Game rules for this Promotion may be amended at any time without notice. To ensure that you are reviewing the current version of the Official Rules for this Promotion, visit www.sceducationlottery.com or obtain a copy by calling 803-737-2002, between the hours of 8:30 a.m. and 5:00 p.m., Monday through Friday.
5. The Promotion is void where prohibited by law.
6. **BY SUBMITTING AN ENTRY, AN ENTRANT IS BOUND BY THE OFFICIAL RULES OF THIS PROMOTION.**
7. **SCEL MAY USE, WITHOUT LIMITATION, AN ENTRANT'S NAME, IMAGE AND LIKENESS AND HOMETOWN IN ANY PROMOTION(S), RESEARCH, MARKETING, PUBLICATION(S) OR ADVERTISING MEDIA INCLUDING, BUT NOT LIMITED TO, THE SCEL WEBSITE AND/OR MOBILE APPLICATION, WITHOUT NOTICE, COMPENSATION OR ADDITIONAL RELEASE. WINNERS OF THE GAME DAY CASH EXPERIENCES IN THIS PROMOTION WILL NOT HAVE AN OPTION TO CLAIM ANONYMITY IF SELECTED.**
8. The odds of being selected or not being selected in this Promotion depend on the number of entries submitted.

B. PRIZES²

No prize element may be subject to substitution, exchange, cash substitution, assignment, or transfer. Any unused, rejected, and/or undeliverable elements of the prize will be forfeited, will not be redeemable for cash, and may not reduce the value of any portion of any Prize for tax reporting purposes.³

² All GAME DAY CASH Prizes include a net prize value; the total GAME DAY CASH Prize value will include applicable Federal and State taxes as required by law and paid by SCEL on behalf of the prize winner. The total value of each Clemson Season Ticket Package is seven thousand, two hundred, forty six dollars and zero cents (\$7,246.00) and the total value of the Carolina Season Ticket Package is twelve thousand, four hundred five dollars and zero cents (\$12,405.00) and these values includes applicable Federal (24%) and State (7%) income tax withholdings. Prizewinners may dispute any tax amounts withheld pursuant to § 59-150-330 of the South Carolina Code as may be authorized by law. SCEL will issue IRS form W2-G to all Prizewinners. **Each prizewinner's ultimate tax liability will depend exclusively upon the winner's other personal income and deductions and is the sole responsibility of the Prizewinner.**

Applicable State and Federal income tax withholdings are included in the value of the GAME DAY CASH EXPERIENCE Prizes and/or the SEASON TICKET Prizes. The Winner's ultimate tax liability will depend exclusively upon the Winner's other personal income and deductions. See Footnote 2 for further information. **Any debt set-off balance must be satisfied in accordance with S.C. Code Ann. § 59-150-330 before any prize is awarded in this Promotion and the Winner must provide SCEL documentation of debt satisfaction from the SC Department of Revenue by a deadline imposed solely by SCEL. If outstanding debt set-off is not satisfied by the deadline decided by SCEL for GAME DAY CASH EXPERIENCE Winners, then prior to the GAME DAY CASH EXPERIENCE the Winner must agree in writing to assign any prize winnings from the GAME DAY CASH EXPERIENCE toward satisfaction of any debt set-off. Failure to satisfy debt set-off before the GAME DAY CASH EXPERIENCE or failure to provide a written agreement to assign prize winnings toward satisfaction of any debt set-off at a time decided solely by the Lottery will cause the GAME DAY CASH EXPERIENCE prize to be forfeited and an alternate will be promoted.**

1) GAME DAY CASH EXPERIENCES

One (1) Clemson Football Cash Experience

One (1) Carolina Football Cash Experience

SCEL will conduct one (1) draw to select one (1) winner of a Clemson Football Cash Experience and will conduct one (1) draw to select one (1) winner of a Carolina Football Cash Experience. Each winner will participate in a live cash experience at a (to be determined) home football game of the Prize's designated university football team. The winner will be provided a chance to win up to fifteen thousand dollars (\$15,000) at the designated live athletic game. A minimum prize of five thousand dollars (\$5,000) will be awarded. Participation in each live Cash Experience is required to be awarded the cash prize.

SCEL will provide each Game Day Cash Experience Winner admission at the select athletic event for the Winner and one (1) guest and a parking spot. Both seat selection and the parking spot location will be determined in the discretion of SCEL. Game Day Cash Experience prizes do not include any costs associated with lodging, mileage, food, or beverages. See Section F. (3) for further terms and conditions.

One (1) Clemson Basketball Cash Experience

One (1) Carolina Basketball Cash Experience

SCEL will conduct one (1) draw to select one (1) winner of a Clemson Basketball Cash Experience and will conduct one (1) draw to select one (1) winner of a Carolina Basketball Cash Experience. Each winner will participate in a live cash experience at a (to be determined) home basketball game of the Prize's designated university basketball team. The winner will be provided a chance to win up to fifteen thousand dollars (\$15,000) at the designated live basketball game. A minimum prize of five thousand dollars (\$5,000) will be awarded. Participation in each live Cash Experience is required to be awarded the cash prize.

SCEL will provide each Game Day Cash Experience Winner admission at the select athletic event for the Winner and one (1) guest and a parking spot. Both seat selection and the parking spot location will be determined in the discretion of SCEL. Game Day Cash Experience prizes do not include any costs associated with lodging, mileage, food, or beverages. See Section F. (3) for further terms and conditions.

One (1) Carolina Baseball Cash Experience

One (1) Carolina Baseball Cash Experience

SCEL will conduct one (1) draw to select one (1) winner of a Clemson Baseball Cash Experience and will conduct one (1) draw to select one (1) winner of a Carolina Baseball Cash Experience. Each winner will participate in a live cash experience at a (to be determined) home baseball game of the Prize's designated university basketball team. The winner will be provided a chance to win up to fifteen thousand dollars (\$15,000) at the designated live basketball game. A minimum prize of five thousand dollars (\$5,000) will be awarded. Participation in each live Cash Experience is required to be awarded the cash prize.

SCEL will provide each Game Day Cash Experience Winner admission at the select athletic event for the Winner and one (1) guest and a parking spot. Both seat selection and the parking spot location will be determined in the discretion of SCEL. Game Day Cash Experience prizes do not include any costs associated with lodging, mileage, food, or beverages. See Section F. (3) for further terms and conditions.

WINNERS OF THIS PROMOTION WILL NOT HAVE AN OPTION TO CLAIM ANONYMITY IF THEY ELECT TO PARTICIPATE IN ANY GAME DAY CASH EXPERIENCE AND WILL BE REQUIRED TO SIGN AN APPEARANCE RELEASE AND WAIVER OF ANONYMITY. Each GAME DAY CASH EXPERIENCE event may be selected to be broadcasted on SCEL's YouTube page, SCEL's live feed, and other social media outlets. If a Prizewinner chooses to decline participating a GAME DAY CASH EXPERIENCE, the prize will be forfeited and an alternate will be selected.

1) 2023-2024 SEASON TICKET PRIZES⁴

SCEL will conduct one (1) draw to select four (4) winners of a 2023-2024 Clemson Season Ticket Package and will conduct one (1) draw to select four (4) winners of a Carolina Season Ticket Package. Each Clemson Season Ticket Package shall include four (4) tickets to Clemson's football, men's basketball, women's basketball, baseball, softball and men's soccer athletic games/matches. Each Carolina Season Ticket Package shall include four (4) tickets to Carolina's football, men's basketball, women's basketball, and baseball athletic games. These packages do not include any post-season athletic events, and does not include lodging, parking, mileage, food, or beverages. Seat selections will be in the sole discretion of each University.

C. HOW TO ENTER THE PROMOTION

If an entrant has an impairment that calls for assistance with entering information on the ticket, SCEL can provide assistance prior to submitting the entry.

- 1) **To be eligible to enter the Promotion, an entrant must be at least eighteen (18) years of age.**
- 2) **Entries only can be entered electronically either via the SCEL website or the SC Lottery Players' Club mobile application. Mail entry is not applicable in this Promotion. All mail entries will be disqualified.**
- 3) **To obtain the SC Lottery Players' Club App, go to Google Play™ or the App Store and download the SC Lottery App.**
- 4) **To enter the Promotion, an entrant must be a registered member of the SCEL Player's Club.**
- 5) **If you are not already a member of the SCEL Player's Club, join using the SC Lottery App or go to the SCEL website. To join the SCEL Player's Club via the SCEL website, entrants must go to www.sceducationlottery.com and click on the Rival Play Second-Chance Promotion link. The link will forward the entrant to the Promotion webpage. On the Promotion webpage, click the "Register" link to begin registration. To join the SCEL Player's Club on SC Lottery App, click the "Join SCEL Player's Club" link.**

Entrants must accurately complete all required information blocks in their Players' Club account including, but not limited to, his or her (legal) first and last name, best contact telephone number(s), e-mail address, street address (including city, state, and zip code) and date of birth. Once completed, entrants will receive a confirmation email at the email address provided at registration. Junk mail folders or spam mail folders should be checked if not received right away. Once an entrant has confirmed his or her registration, the entrant can log into his or her account using a smartphone, tablet, or computer.

Submitting incorrect, fictitious, or erroneous information in the required fields for a Players' Club account may result in disqualification of an electronic entry in this Promotion. Only one person may be listed for a Players' Club account, i.e., an entry with more than one name such as "Mr. and Mrs. Jones" or "John and Mary Jones" will be disqualified.

- 6) **After Players' Club account registration is complete, entry in the Promotion may be done via the SCEL website or the SC Lottery Players' Club App.**

To enter the Promotion on the SCEL website, an entrant must submit the eleven (11) digit ticket identification number on the front of the ticket and the six (6) digit ticket identification number from the back of a single winning or non-winning CLEMSON JACKPOT scratch-off ticket or CAROLINA JACKPOT scratch-off ticket (Game SC-1419 or Game SC-1420).

To enter the Promotion on the SC Lottery Players' Club App, scan the barcode under the scratch area of a winning or non-winning CLEMSON JACKPOT scratch-off ticket or CAROLINA JACKPOT scratch-off ticket (Game SC-1419 or Game SC-1420).

For each winning and non-winning CLEMSON JACKPOT scratch-off ticket and CAROLINA JACKPOT scratch-off ticket (Games SC-1419 and Game SC-1420), the entrant will have the opportunity to choose either:

- a) an entry into a pool for a chance to win the Clemson Football or Basketball Cash Experience between August 23, 2022 – October 11, 2022; or**
- b) an entry into a pool for a chance to win the Carolina Football or Basketball Cash Experience between August 23, 2022 – October 11, 2022; or**
- c) an entry into a pool for a chance to win the Clemson Baseball Cash Experience between October 12, 2022 – February 6, 2023; or**
- d) an entry into a pool for a chance to win the Carolina Baseball Cash Experience October 12, 2022 – February 6, 2023; or**
- e) an entry into a pool for a chance to win the Clemson Season Ticket Package between August 23, 2022 – February 6, 2023; or**
- f) an entry into a pool for a chance to win the Carolina Season Ticket Package between August 23, 2022 – February 6, 2023.**

Each RIVAL PLAY scratch-off ticket, whether it is a winning or non-winning CLEMSON JACKPOT scratch-off ticket (Game SC-1419) or a winning or non-winning CAROLINA JACKPOT scratch-off ticket (Game SC-1420) may enter any of the listed pools available at the time of entry, regardless of university affiliation. For instance, a winning or non-winning CLEMSON JACKPOT scratch-off ticket can be entered into a pool for a chance to win a prize associated with a CAROLINA prize package, and vice versa. Each ticket can only be entered once in the Promotion. Once a ticket has been submitted, the school selection and/or prize selection cannot be changed.

Winners of the GAME DAY CASH EXPERIENCE prizes for the football and basketball pools will not be able to choose between the football or basketball games, and the specific game will be chosen solely by SCEL.

- 7) Once the electronic entry system accepts the required ticket information from a CLEMSON JACKPOT scratch-off ticket (Game SC-1419) or CAROLINA JACKPOT scratch-off ticket (Game SC-1420), the same ticket information will not be accepted a subsequent time for the duration of the Promotion.**
- 8) "Live" or winning and non-winning CLEMSON JACKPOT scratch-off tickets and CAROLINA JACKPOT scratch-off tickets CAN be entered electronically in the Promotion.**

- 9) Although the original Qualified Entry ticket is not required when presenting a claim, players are strongly encouraged to retain tickets submitted electronically until after the draw.
- 10) A ticket other than a CLEMSON JACKPOT scratch-off ticket or CAROLINA JACKPOT scratch-off ticket (Game SC-1419 and Game SC-1420) is ineligible for electronic entry into the drawing and will be disqualified. Electronic entries that fail to provide the required information will be disqualified. Entries submitted electronically after the deadline will not be entered into any draw.
- 11) Tickets will be verified at time of entry to ensure they are eligible for the Promotion. Each ticket can only be entered one (1) time. Entries that include tickets with invalid ticket numbers will be disqualified.
- 12) Entries will be maintained in a secure database. Data collected in the course of a promotion is stored on secure servers within a guarded limited access hosting facility. Access to data is protected by a variety of security measures.
- 13) **The risk of loss for, to include but limited to, electronic mis-delivery, late delivery, or failure of receipt for ticket information entered electronically in the Promotion remains with the entrant, regardless of the cause of the failure of transmission.**
- 14) A Qualified Entry cannot be entered by mail for this Promotion. This Promotion will only accept entries by **ELECTRONIC SUBMISSION**.
- 15) **Entries for the CASH EXPERIENCE prizes will not roll over to the next drawing.**

D. DRAW

1. Entries must be received no later than 11:59:59 p.m. on the **entry deadline(s)**. Entry deadlines may vary depending on Prize.

3. The Draw(s) will be conducted under the supervision of an independent auditor, who will audit each drawing and will certify each drawing as provided in the Draw Procedures. The Draw(s) will take place at SG's offices located in Alpharetta, Georgia on the date designated in the above chart. Both the place and time for a draw may be changed without written notice or amendment to the Rules.
4. If a foul is declared during the Draw(s), the selection process shall be halted and the Director of Security, or a designee, will void or reinstitute the process he or she deems appropriate.
5. Four (4) winners will be selected on the first draw date: one (1) winner for the Clemson Football Cash Experience, one (1) winner for the Clemson Basketball Cash Experience, one (1) winner for the Carolina Football Cash Experience and one (1) winner for the Carolina Basketball Cash Experience. On the second draw date, ten (10) winners will be selected: one (1) winner for the Clemson Baseball Cash Experience, one (1) winner for the Carolina Baseball Cash experience, four (4) winners for a Clemson Season Ticket Package and four (4) winners for a Carolina Season Ticket Package. If the first selected entrant(s) fails to qualify, the next entrant(s) selected in that drawing will be eligible for qualification in descending order of selection.
6. Entries received after the entry deadline(s) will be discarded at the discretion of the SCEL Director of Security, or his or her designee.

NOTICE FOR GAME DAY CASH EXPERIENCE: Prizewinners will participate in a live cash experience at a (to be determined) home athletic game, depending on the Game Day Cash experience selected and awarded, of the Prize's designated college team. The winner will be provided a chance to win a cash prize valued at either \$5,000 (Total value of \$7,246 plus costs related to price of admission tickets and parking spot, including applicable taxes paid by SCEL), \$10,000 (Total value of \$14,493 plus costs related to price of admission tickets and parking spot including applicable taxes paid by SCEL), or \$15,000 (Total value of \$21,739 plus costs related to price of admission tickets and parking spot including applicable taxes paid by SCEL) at the live game.⁵ The value of each cash prize will be predetermined in a separate and independent cash prize draw ("CPV"), using a ball machine at the SCEL Business Office. Each CPV Draw will consist of ten (10) balls: two (2) balls representing a \$5,000 cash prize, three (3) balls representing a \$10,000 cash prize, and five (5) balls representing a \$15,000 cash prize. Each CPV Draw will be conducted by

a member of the SCEL Security Department and in the presence of an independent auditor, in accordance with the Rival Play Cash Experience Prize Value Draw Procedures. Each CPV Draw will be videoed and available for viewing after the GAME DAY CASH EXPERIENCE has been conducted for each event and after the cash prize has been revealed and awarded.

In the event the Prizewinner suffers from a disability or physical ailment preventing participating in a GAME DAY CASH EXPERIENCE, a Prizewinner may designate a proxy ("Proxy") subject to SCEL approval, or have one chosen by SCEL to participate in the GAME DAY CASH EXPERIENCE. Neither Prizewinner nor Proxy will be permitted to remain anonymous and both will be required to sign an Appearance Release and Waiver of Anonymity. The Prizewinner and Proxy must be 18 years of age or older to be eligible to participate in a GAME DAY CASH EXPERIENCE event. Any prize resulted from a GAME DAY CASH EXPERIENCE shall be attributed to the Prizewinner and the Prizewinner shall have no further opportunities to participate in the particular GAME DAY CASH EXPERIENCE.

Prizewinners and or Proxys will be expected to maintain an appropriate standard of dress, personal appearance, and decorum. Prizewinners and/or Proxys will not be permitted to wear any clothing reflecting any logo(s) or inappropriate graphics, profanity, or political and/or religious messages. All attire, including appearance, must be approved solely in the discretion of SCEL, and a proxy, in SCEL's sole discretion, may be appointed by SCEL at any time. Prizewinners and/or Proxys may be required to wear alternative clothing in the sole discretion of SCEL. All winners acknowledge that behavior in a disorderly or disruptive manner, to include intoxication, and determined in the sole discretion of SCEL, may result in disqualification from participation in the live experience and a proxy designated by SCEL.

One (1) guest will be allowed to attend the game with the GAME DAY CASH EXPERIENCE Winner, but will not be permitted to participate in the live portion of GAME DAY CASH EXPERIENCE. Guests under ten (10) years of age must be approved by SCEL.

E. QUALIFICATION AND VALIDATION OF WINNERS

- 1. There is only one (1) winner for each Game Day Cash Experience draw in this Promotion. There are only four (4) winners for each Season Ticket Package draw in this Promotion. More than one prize cannot be won in this Promotion.**
2. SCEL employees, MDI and SG employees, IGT employees, and/or dependents or family members residing in the household of any of these employees, or any other person ineligible to purchase South Carolina lottery tickets pursuant to Title 59, Chapter 150 of the South Carolina Code of Laws, are ineligible to enter this Promotion. Auditors who routinely perform work for SCEL and advertising firm employees who performed work for this Promotion are also ineligible to enter.

3. Disqualification of an entry may occur at the time an entry is received or at a later time as may be appropriate or required by these Rules.

4. **Notification of the Winner:**

(a) SCEL will contact each winner via (i) phone call at the phone number provided, (ii) email at the email address provided, and/or (iii) certified mail or commercial overnight delivery service. ⁶

(b) Each winner must complete the claim form, provide all information necessary to process the claim, and submit it to the SCEL Claims Office via mail or in person to receive the Prize. The SCEL Claims Office in Columbia, S.C. must receive the completed claim form with all information requested by SCEL by close of business on the date and time requested by SCEL. If the completed claim form and other information requested are not received by the date and time requested, the winner will be disqualified and replaced with an alternate in order drawn pursuant to the Draw Procedures. SCEL assumes no responsibility for, including but not limited to, incorrect addresses, mis-delivery, late delivery, stolen items, or failure of delivery for any reason for any item(s) sent pursuant to this paragraph by either SCEL or the winner, regardless of fault. **All risk of loss remains with and is assumed by the entrant.**

Prize winners of the GAME DAY CASH EXPERIENCES may be required to complete and submit a claim form before the live event, as directed by SCEL.

(c) The name and other contact information submitted on the claim form must match the name and other contact information provided when submitting an electronic entry. If the person submitting the claim form is different from the person who submitted the entry, both individuals are subject to disqualification.

(d) The information submitted on the claim form is subject to additional validation and verification of eligibility by SCEL. The selected entrant is subject to disqualification if eligibility requirements are not met.

5. **AN ENTRANT SELECTED AS A WINNER ASSUMES THE RISK OF LOSS AND IS SUBJECT TO DISQUALIFICATION IF: (a) SCEL IS UNABLE TO CONTACT THE WINNER; (b) INFORMATION, AS SPECIFIED BY SCEL, IS NOT TIMELY RECEIVED FROM THE WINNER; OR (c) ANY OTHER REQUIREMENT UNDER THESE RULES IS NOT MET.**

6. If an entrant selected as a Winner is deemed ineligible or disqualified under any of these Rules, the Alternate must qualify no later than the time specified by SCEL. An Alternate is subject to the same terms and conditions provided in Paragraph 4 of this Section.

7. A DECISION BY SCEL TO PROCEED TO NOTIFICATION AND QUALIFICATION OF AN ALTERNATE IS WITHIN THE SOLE DISCRETION AND JUDGMENT OF THE EXECUTIVE DIRECTOR, OR HIS OR HER DESIGNEE. THE DECISION OF THE EXECUTIVE DIRECTOR, OR HIS OR HER DESIGNEE, IS EFFECTIVE UPON THE TIME AND DATE THE WRITTEN DETERMINATION IS MADE TO PROCEED WITH AN ALTERNATE AND MAY NOT BE RESCINDED.
